How Mayor James Butts turned Inglewood Into California's Premier Sports and Entertainment City


While many cities in Southern California and throughout the nation are wrestling with the economic and health impacts and fallout of the COVID-19 pandemic – laying off hundreds of employees, reducing municipal services to residents and delaying the completion of long-promised projects – the City of Inglewood is a sharp study in contrast. While also managing the consequences of the pandemic and ensuring the safety of both its citizens and staff, the Inglewood economic renaissance is not only keeping its momentum, it is also gathering speed.

The world's most famous one-day sports event, Super Bowl XVI, will take place in the new \$5 billion dollar SoFi Stadium in February 2022, but that is only one of many international sporting events slated to take place in Inglewood. Others include Wrestlemania, the FIFA Soccer World Cup and the opening ceremony of the 2028 Summer Olympics.

Even in these challenging times, Inglewood's transformation from a South Bay city that once made headlines for its economic and crime struggles, has morphed into an economic powerhouse and development oasis that has attracted three professional sports teams – the Rams, the Clippers and the Chargers. It has become the home to the headquarters of the Girl Scouts of Greater Los Angeles, as well as the L.A. Philharmonic's Youth Orchestra program and its Frank Gehry-designed headquarters. Inglewood stands out as Southern California's most remarkable story of transformation and triumph.

Beach City Chief, South Bay City Mayor Compare Inglewood to its neighbors to the south and the west. Or simply compare it to nearby Santa Monica.

The coronavirus outbreak has shut down tourism, drying up the beach city's two main streams of revenue, hotel bed taxes and sales taxes. At the same time, it did not heed years of warnings about its enormous pension debt, and now, with severely reduced

revenues, is paying the price. Santa Monica is now looking at a \$226-million shortfall by June of 2021 and has authorized the lay-

offs or buyouts of 373 full time employees.

By contrast, Inglewood has enough reserves to see it through this fiscal

year without furloughs or layoffs. It dramatically reduced its unfunded liabilities by eliminating non-funded lifetime re-

tiree medical program and replacing it with an employee health savings plan.

New Cal NAACP Chief Appoints Sac Woman Executive Director

The new president of the National Association for the Advancement of Colored People (NAACP) California-Hawaii State Conference is keeping in step with a national movement making strides to level the playing field for Black women -- long underrepresented in both private and public sector leadership roles. Like organizations and companies around the country, California's conference of the oldest civil rights organization in the country is leading by increasing professional opportunities and offering critical career support for Black women.

Kickstarting his tenure, the NAACP State Conference President Rick L. Callender announced last week that Betty Williams has been hired as the organization's executive director.

Williams, a longtime president of the Sacramento branch of the NAACP, calls her new statewide

position a "blessing."

"I had thought about it, and it was like, 'God this is my passion, I love the organization, I love the advocacy of civil rights, and being that voice (of NAACP) for almost 10 years,'" Williams told California Black Media (CBM). "I want to be a part of an organization that I absolutely adore, part of the decision-making process, the transition, and Rick Callender's vision of taking all the branches to a whole new level."

Williams was appointed with the full support of the State Conference board. In her new role, Williams will help Callender represent the organization and oversee the operations of 55

branches in California and Hawaii, serving as a spokesperson and monitoring developments in politics at the State Capitol.

Under Williams's leadership as the Sacramento branch president of the NAACP, she helped law enforcement agencies in Sacramento develop community partnerships that contributed to the reduction of crime and safer communities in some of the most underserved areas of the city.

Williams was also instrumental in effecting changes to economic and social policies in the Sacramento region. Her peers praise her for pushing for reforms in policing strategies, including police-use-of-force procedures.

"She is the right person at the right time to lead the California-Hawaii NAACP into the future," said Callender, who is also the chief executive officer of the Santa Clara Valley Water District.

Callender has joined NAACP Chairman of the Board Leon Russell to fire up the organization's members and delegates to become more engaged in the civic life of their local communities. He is also focused on promoting the participation of more Black women in politics in the state.

Callender and the California-Hawaii NAACP supported a resolution calling for Gov. Newsom to appoint an African American woman to fill the U.S.

Senate seat that will be vacant once Kamala Harris is sworn in as Vice President of the United States next month.

"The California voters sent a Black woman to the U.S. Senate. She was, and is, the only Black woman in the U.S. Senate," Callender stated. "It's the right thing that should be done. Let's all mobilize to make this happen."

Callender, former president of the San Jose-Silicon Valley NAACP, was appointed president of the California-Hawaii State Conference of the NAACP in November.

He assumed duties Dec. 1 after Alice Huffman stepped down due to health concerns. Huffman held the position for 21 years.

Gov. Newsom Appoints Two Black Women to Air Board

Months after Black employees called out widespread racism at the California Air Resources Board (CARB), Gov. Gavin Newsom has appointed two African American women to the board of the California agency that shapes state policy against air pollution.

Last week, the governor announced that he appointed Liane Randolph, 55, of Oakland, who was in charge of integrating the resource-planning processes at the California Public Utilities Commission (CPUC), as the new chair of CARB.

"Cleaner air is essential for California's families and Liane Randolph is the kind of bold, innovative leader that will lead in our fight against climate change with equity and all California's communities at heart," Gov. Newsom said. "By committing to achieving carbon neutrality and a clean economy, my Administration is fighting for a healthier and more vibrant future for our families and our economy."

Randolph is the first Black person to serve as chair of CARB.

Responding to the news of her appointment, Randolph said she is "beyond excited" about the work she will do at CARB.

"Governor Newsom and the Legislature have set California on a bold

path to address the air pollution that burdens our communities and the existential threat of climate change," Randolph said. "Implementing these policies requires effective management and strategy that centers the people affected most by environmental damage. I am eager to step forward and continue California's leadership in tackling these challenging issues."

Randolph has been a Commissioner at the CPUC since 2015. Before that, she was deputy secretary and general counsel at the California Natural Resources Agency from

2011 to 2014. From 2007 to 2011, she was an attorney at the law firm Pillsbury Winthrop Shaw Pittman LLP.

Randolph, a Democrat, also served as chair of the California Fair Political Practices Commission from 2003 to 2007. From 1996 to 1997, she was staff attorney there as well.

She holds a Juris Doctor degree from the University of California Los Angeles School of Law. The CARB chairperson's position requires Senate confirmation, and the compensation is \$183,552.

Randolph replaces Mary Nichols, CARB's

outgoing chair, who is reportedly President-elect Joe Biden's top pick to be the next Administrator of the Environmental Protection Agency (EPA).

Another Black woman, Davina Hurt, will also serve on the air agency's board. She joins other members: John Balmes of Berkeley, Los Angeles' Gideon Kracov, and Tania Pacheco-Werner of Sanger.

Hurt, 45, has been a Belmont City councilmember since 2015. She has worked as a campaign manager at the Democratic Volunteer Center from 2014 to 2015.

Hurt is a member of the

Bay Area Air Quality Management District. This CARB board position requires Senate confirmation and there is no compensation. Hurt is also a Democrat.

In September, the Concerned Black Employees at CARB (CBE CARB) submitted a 13-page letter alleging discrimination at the agency. It stated that members had been the target of routine and systematic racism and that they had been excluded from promotions.

CARB, the letter points out, has a total of 1,627 employees and only 73 of them are Black. Only one

African American has held an executive position with the organization.

"Our intent in sharing this Letter and Action Plan is not to shame or belittle CARB, or to assign blame. We enjoy the work we do at CARB and want to do all we can to improve CARB for the future, and our future careers with the agency," CBE CARB stated.

Last summer, at the height of the George Floyd riots and the national reckoning on race, Assemblymember Jim Cooper (D-Sacramento), who is African American, expressed disapproval and disappointment after Nichols posted a tweet comparing air pollution violations with the tragic death of George Floyd.

"How dare you use a dying man's plea for help as a way to discuss your agenda. Have you no shame?" Cooper reacted to Nichols' tweet.

Nichols posted on June 1, "'I can't breathe' speaks to police violence, but it also applies to the struggle for clean air. Environmental racism is just one form of racism. It's all toxic. Government needs to clean it up in word and deed."

Nichols later issued an apology via Twitter, stating "I apologize for speaking at the wrong time about the wrong topic. Racism comes in many forms and I believe we must fight every instance of it in our society."

How Inglewood became the Sports and Entertainment of Southern California

With a COVID-19 vaccine in the offing, it is possible that cuts to staff and services in this South Bay city will be minimal or nonexistent. While the differences between the two cities strain direct comparisons, they do, however, have one powerful factor in common: James T. Butts.

Butts, formerly the 15 year Police Chief of Santa Monica, has been at Inglewood's helm for the past decade, and it is under his leadership that Inglewood has flourished.

Before Covid-19, Inglewood's unemployment rate had plunged from 17.5% to 4.7%, and employment remains a top priority with a 35% local hiring goal for Inglewood residents for the 50,000 construction jobs scheduled over the next 7 years. This means resi-

Inglewood contributed \$18 million of State Redevelopment funds to re-open the doors to the City's most famous landmark.

The question, really the gamble, was whether a major arena could succeed without a resident sports team — revenue the Forum lost when the Lakers moved to Staples Center.

The answer was an emphatic "yes." In its first year back in operation, the renovated Forum hosted 50 paid concerts, including ones by the Eagles and the Wu-Tang Clan -- almost twice as many as the Southern California area's second-place finisher, the Verizon Wireless Amphitheater in Irvine, and double of downtown L.A.'s Staples Center.

"That put us back on the sports-and-entertainment

Then the mayor laid out an alternate proposal:

He articulated the pros of building out the entire project to Stan Kroenke; "The land is less than 2 miles from one of the busiest airports in the United States and the weather is so good here, that when it rains hard, we have to buy new umbrellas because most of us forget where we put our umbrellas."

He said; "If I were you, I would do a joint venture with Stockbridge Capital (the financial arm of Hollywood Park Tomorrow), adopt their entitlements and seek to expand it. titled, back in 2007-2008, and was ready to go. But unfortunately, the recession hit, the housing market had crashed, and the project was dead. When the Forum reopened the Stockbridge Capital group received EB-5 pledges that allowed them to go forward. So when Kroenke approached them, Stockbridge wasn't interested. They had been through the dance with the NFL in the 1990's when Al Davis had negotiated a deal with Hollywood Park and the City to move the Raiders back to the LA market on that same land. Al Davis asked the City for \$10 million dollars non-refundable and Inglewood declined. Al Davis would get that \$10 million non-refundable from City of Irwindale. He never built a stadium in Irwindale and left with the \$10 million and returned to Oakland.

"Stan called to tell me Stockbridge won't sell and they won't even talk about it," the mayor said. "I said okay. Let me see what I can do."

What the mayor would do would be use Inglewood leverage to bring the parties together.

Hollywood Park Tomorrow wanted a minor modification in their development agreement; instead of having to put up a bond for the entire project as soon

um as the centerpiece of a 300-acre development that is 2½ times the size of Disneyland at a cost of about \$5 billion. Inglewood Today Today, the key components of the renaissance are either completed or nearing completion.

Madison Square Garden has gone back to New York and the "Fabulous Forum" is now part of Ballmer's sports and entertainment footprint in Inglewood.

SoFi Stadium is the most magnificent and technologically advanced sport

structure in the world, and the Rams and the Chargers are midway through their first NFL Season in their new home.

The Clippers are edging closer to breaking ground on what will be the preeminent professional basketball arena in the world, and a practice facility, 18,000-seat NBA arena, open space and retail will take shape on land that has lain fallow for over three decades.

The NFL Network building is weeks of being ready for occupancy, and the 298-acre Hollywood Park Development is an aerial landmark for passengers approaching LAX.

In terms of quality of life, the challenges posed by COVID-19 cannot be dismissed. Real suffering has been visited on people who have lost both livelihood and loved ones.

Yet, with regard to public safety, the City continues to create a safer and more security environment.

Inglewood is in its 9th consecutive year of the lowest crime rates in its recorded history. In fact, the year 2019 holds the distinction of having the lowest level of crime in City records.

Lastly, the Inglewood Airport Area Chamber of Commerce, fittingly, is in the final stages of a renovation that will give the organization is due as a key partner in Inglewood's economic turnaround.

"I want to be clear – I haven't done all of this by myself. I have a talented team of City Council Members (Eloy Morales, Alex Padilla, George Dotson and Ralph Franklin) along with our City Manager Artie Fields and our dedicated Department Heads that have worked night and day to make this happen," Butts said. "Overwhelmingly our team is made up of people who live in Inglewood, who are connected to its past, and are deeply

as they broke ground, they wanted to be able to bond piece by piece. That's a change the mayor said he would grant – under one condition.

"I will give you the modification, but only if I feel you've negotiated substantially with Stan Kroenke," Butts conditioned.

And negotiate, they did.

An initiative was put forward by an Inglewood resident. It garnered over 22,000 signatures (far more than what was required to put it on the ballot). The whole city rallied to support the stadium, by supporting the initiative that would allow the entitlements for the expanded retail and office program (the original proposal had a 70,000 seat NFL stadium cleared environmentally) without a new EIR. The City Council adopted the initiative by unanimous vote. An overwhelming majority of residents united to bring the Rams to Inglewood.

With private funds, Kroenke built SoFi Stadium

Halimah Ginyard, President of the Inglewood Airport Area Chamber of Commerce said; "Stan Kroenke's SoFi Stadium project employed over 1,200 Inglewood residents and spent over a half-billion dollars using minority led and disadvantaged businesses as local subcontractors. Stan Kroenke stood tall for Inglewood residents and small businesses....Stan even contracted with Inglewood businesses for catering of milestone construction events"

That's how Inglewood did what many cities across the country had tried to do, land an NFL Team. But Inglewood did it without public funds or securing municipal bond indebtedness.

"We could do it because we aren't Los Angeles. We could do it because we are small enough to have a nimble government that cut through layers of bureaucracy."

What did Inglewood seek in return?

"We knew how great this is going to be for our residents in terms of jobs and diversifying our tax base, so we were going to make it happen — and we did it in a way that worked for the Rams and worked for Inglewood and our residents."

Mayor Butts, who has an MBA from Cal Poly Pomona, says that it is his business background, not experience as a police chief or head of anti-terrorism at Los Angeles World Airports that has been most relevant to the business renaissance of Inglewood.

"It helps that I speak the language of business and understand the concerns those that risk large sums of capital investing in a city," he said simply.

After the Rams came the Chargers. Then came the Los Angeles Clippers and owner Steve Ballmer, determined to build a state-of-the-art arena for his

President-Elect Joe Biden Taps Former Ambassador Susan Rice for White House Domestic Council

The vision of inclusion continues to take shape in America. President-elect Joe Biden selected former ambassador of the Obama administration Susan Rice to lead the White House Domestic Policy Council. Biden's "Build Back Better" mission is showcasing its effect, by rendering his future administration to focus on racial equity, healthcare, and the ever-present coronavirus pandemic.

At age 56, Rice has amassed over 20 years' experience in foreign policy; her recent activity seen through the Obama administration as Ambassador of the United Nations. Rice later filled the role of a national security advisor. According to reports from CNN, her potential influence as leadership for the White House Domestic Policy Council "will elevate the profile" in the Biden cabinet, and create a sense of recovery from the previous presidential party

activity.

Rice has the potential to join other significant presidential advisors, which includes Democrat Leon Panetta and Republican James Baker; they concentrate on foreign policy and domestic initiatives. From, circulating reports from Yahoo News, democratic policymakers have contested Rice's ability to receive approval from a "Republican-controlled" senate branch. secure a place for Rice in his administration. A key connection between Biden and Rice was in 2008, they worked closely in the Obama administration. When Biden was active as Vice President and Rice served as the UN ambassador, both sides led activi-

ties that may have overlapped. As a promising contender, Rice will supervise the development, coordination, and execution of domestic policy in the White House.

As the potential leader of White House Policy, Rice will work directly with the

administration aligned with its set agenda. Rice would manage the department's staff and interns in specific policies that include education, energy, environment, healthcare, immigration, infrastructure, labor, urban affairs, and veteran matters according to the official website of the White House.

Reflecting on the information found on Ballotpedia, former ambassador Rice was born in Washington D.C. in 1964, and she received her bachelor's degree in history from Stanford University. Rice continued her education at Oxford University where she earned her Master's in Philosophy (M.Phil) and a Doctor in Philosophy (D.Phil) in International relations.

Digging deeper into her background, Rice had a leading role as an international management consultant at McKinsey and Company in Toronto, Ontario in 1993. Expanding her political influence over the years, Rice had a hand in the Clinton admin-

istration. She was a member of the National Security Council, as director for international organizations and peacekeeping. Gradually, she became a special assistant to 42nd President Bill Clinton.

In 1997, Rice was recommended for the assistant secretary for the African Affairs position. She served under that title until 2001, Rice took on a senior position in foreign policy at the Brookings Institute soon after. She came back to Capitol Hill in 2008, to become the Ambassador to the United Nations and national security adviser from 2009 to 2017.

A key part to Biden's "Build Back Better" Initiative is racial equity. In partnering with Vice-President Kamala Harris, selecting former General Lloyd Austin for Pentagon leadership, and now preserving Rice for White House Domestic Policy, Biden is showing the authenticity in his mission. The vision for a diverse population within the Biden Cabinet is well underway.

SC-VBC PROVIDES ONLINE RESOURCES AND COURSES FOR ENTREPRENEURS

The Southern California Virtual Business Center (SC-VBC) is an online facility designed to prepare business owners to scale and grow through the emphasis of corporate and government contracts. The SC-VBC hosts different programs for entrepreneurs at different stages of their busi-

ness, through the program's curriculum, resources, and mentorships.

On Wednesday, December 11, 2020—The Los Angeles Sentinel (LAS) interviewed Founder and Program Director of the SC-VBC—Kimberly Kelly-Rolfe. We discussed topics like entrepreneurship, how to secure largescale partnerships, the significance of today's digital market, and

starting a business during the pandemic. The following is a Q&A, but for the full interview go to www.lasentinel.net.

(LAS): Kimberly, for those who are not aware, how did you get to where you are today?

(K): I would say tenacity, a lot of hard work, and just a determination to succeed are probably my biggest success factors. I

always think back to something that I used to say in High School, "If there is a will, I will find a way! That's sort of been my life's moto, I suppose."

(LAS): Let's talk about Southern California Virtual Business Center, what is your role with this program and what is the program's objective?

(K): So, I am the director of the Southern California Virtual Business Center (SC-VBC), and our focus is that we are a center that focuses completely on preparing businesses to scale and grow through contracting. So, we do not offer a lot of different programs on different topics. Simply, all our programming focuses on how to prepare businesses to scale and grow through corporate and government contracts because we believe in a long-term sustainability of contracts. It is a true way that business owner can succeed.

(LAS): Are there any qualifications for enrolling in the SC-VBC?

(K): Typically, in order to work with our center, you have to enroll in one of our programs. We have three programs that we offer, and they are for entrepreneurs at different stages. So, our newest program which we are launching in 2021 is called—The Large Incubator. That program is for entrepreneurs who are looking to start a business that is conducive to contracting, or maybe your someone who is recently laid off, as a result of the pandemic, and you want to now pursue entrepreneurship. We are going to train and teach you how to create a business that would be conducive to corporate and government contracts.

(LAS): Do you think a student would get a better education by enrolling to SVCBC's program over, let's say a Junior College or Extension Program?

(K): It really depends on what your objective is, if your someone who is looking to scale and grow a business with contracts, by all means, start with the SC-VBC. If you are someone who is still trying to find their way a little bit, and maybe there is a specific topic that you want to pursue; by all means, look into the extension program. And I am going to tell you that,

as an educator and a business owner, I am a firm believer in education and continuing that education. I believe there is so much you can learn!

(LAS): Let's talk about some of SC-VBC's partnerships, and how did that come together?

(K): We have been fortunate to create partnerships with a number of different corporations. [Some] of our biggest partners and proponents of our program are Southern California Edison, we have also received significant funding from JPMorgan Chase & Co., Bank of America, and now we are entering into a new partnership with the California Black Chamber of Commerce. In terms of the partnerships, our mindset was "How do we support our small businesses?" "How can we provide them with the resources and the relationships that they need to scale and grow?" One of the things that we do in our CBEST program is we actually foster a relationship between corporate partners and our small businesses because we recognize that as they're seeking to submit RFP and Proposals, we want to make sure that somebody on the side of the table knows their name and truly understands what they bring to the table. We work very closely with our business and our partners to bring them into a relationship, and that's important to us because we need to give our small businesses all the tools that they need in order to succeed. So, every partnership that we have pursued is with the mindset of continuing to provide resources and

support to small businesses.

(LAS): What does a strong digital plan for a small business look like? Is there an ideal outline?

(K): I think that it's unique for each business. I think that every business has the responsibility to explore their market. Meaning, what are the trends in your industry? What new technology is heading your way? What opportunities/problems do you see in the market that have not been solved? So, when you are thinking of providing a digital solution for your own company, it's what resources can we utilize and tap into that's going to keep us connected to our customer. What's going to keep us operating efficiently? I guess if I were to breakdown our digital plan or programming, I would want to make sure it definitely includes: a social media platform to make sure we are staying connected, I'm looking at CRM—Customer Relation Platform, and also a dashboard that's going to keep all the functionality of the company at the fingertips of the management.

(LAS): What advice do you have for anyone who would like to start a business during the pandemic?

(K): You're going to have to be creative. You're going to have to be innovative. I think what we have done in the past may not necessarily work. The reason is now businesses are forced to be able to service customers in-person and online. You've got to have a good strong plan for both because some people still

At the forefront of every platform Ridley-Thomas has stepped on, the mission for racial equity has always been present. Ridley-Thomas demonstrated his understanding of justice for all, in directives such as the ATI/ODR, and the Anti-Racism motion. More recently in his career, Ridley-Thomas orchestrated a six-page measurement, addressing institutionalized racism among the County walls of Los Angeles. In July, he made the call for recourse and a movement for anti-racist sensibility.

Supervisor Ridley-Thomas held a virtual briefing, and broke down the benchmarks of the "establishing an anti-racist Los Angeles County policy agenda." During the wake of health and wellbeing, there needed to be an immediate action for equality for people of color in Los Angeles.

The COVID-19 outbreak did not distinguish the fire Ridley-Thomas had for equity. He did more than hold virtual meetings and socially distanced discussions. Ridley-Thomas physically moved and sought to help the community by providing them with supplies needed to waiver this viral pandemic. In May, Ridley-Thomas rallied for unincorporated areas to receive 1.8-million dollars in federally funded emergency rental assistance.

Areas under the second-district jurisdiction include Athens, East and West Rancho Dominguez, Florence Firestone, Ladera Heights, Lennox, View Park, Windsor Hills, and Willowbrook. Within his latest acts during the COVID-19 pandemic, Ridley-Thomas traveled for several weeks and passed out over 10,000 masks to essential workers across the second-district.

Since the pandemic has escalated to over 200,000 cases, masks have been in high demand. With the majority of Personal protective equipment (PPE)

determination, Ridley-Thomas saw monumental works come to pass. He has devoted much of his life's energy to the betterment and improvement of Los Angeles.

issue of our time."

Working diligently right up to the brink of the COVID-19 outbreak, Ridley-Thomas spoke at the Safe Landing project in early February. As previously noted, Safe Landing was an initiative created to

reserved for medical centers and first responders, Jobs in underserved communities are left with even fewer preventative resources. This environment leaves them exposed to the risk of community transmission.

This created tremors that could engulf underserved neighborhoods. Ridley-Thomas has shown persistence, unwavering commitment, and the necessary level of work needed to be done in the community.

Reflecting on his time in public service, Ridley-Thomas said, "I find this work fulfilling. I deliberately chose to stay here all

of my life, because I see so much opportunity to do good—to make a difference." Ridley-Thomas continued, "To me, that is what life is about, so it's pretty natural for me to salute servant leadership,

and that is essentially what I do." The community looks forward to the continual devotion and civic duty Councilmember Ridley-Thomas will put forward in the coming changes of history.

LA County Small Business Owners Face \$60 Billion Capital Gap, Magnified Due to Pandemic

A new report found that minority-owned small businesses in Los Angeles County face a \$60B capital gap and suffer disproportionate revenue losses and closure rates as a result of the COVID-19 pandemic.

The report written by Next Street and Common Future explains that small business revenue in Los Angeles County decreased by 26 percent from January to September 2020. During the same period, the number of small businesses open for business fell by 27 percent.

Black, Latinx, and Asian-owned businesses across Los Angeles County are overrepresented in

industries directly impacted by the pandemic including restaurants, performing arts venues, and personal and laundry service businesses, according to the study.

“Despite boasting the largest small business economy in the country, Los Angeles small businesses continue to feel the strain of inequality, disenfranchisement, and discrimination,” says Charisse Conan Johnson, managing partner at Next Street.

According to the report, the situation in Los Angeles is also similar across the country as businesses owned by people of color reported nearly twice the closure rates and revenue losses compared to White-owned firms

during the first two months of the pandemic nationally.

The report’s researchers attribute these disparities to systemic barriers to accessing affordable capital and high levels of segregation that restrict access to networks and opportunities to build wealth through business ownership.

“Our new report on Los Angeles small businesses shows that geography, class, and race matter significantly when it comes to the success of a

business. They just need more capital providers to step up and support them to survive in this tough

The report was commissioned by JPMorgan Chase and developed in partnership with Lendis-

strengthen businesses and corresponding responsible capital providers.

Sarah Bowles, vice president of Global Philanthropy for JPMorgan Chase, commented on the research, “This research is important to identify the right support and resources needed in Los Angeles to help diverse

economic time, and to thrive beyond it,” says Rodney Foxworth, CEO of Common Future.

The report finds that while Black and Latinx residents make up 8 percent and 49 percent of L.A. County’s population, they only own two percent and 11 percent of all local businesses, respectively.

It goes on to provide community-informed solutions to address the immediate issues facing minority-owned small businesses, including increasing the availability of free and low-cost, flexible capital and money to better finance and

This past Friday, December 10, 2020, Metro's CBO hosted a virtual meeting to discuss the strategy and recommendations with community leaders across Los Angeles.

As stated in the draft, "The CBO Strategy establishes clear and consistent parameters for Metro to continue partnering with CBOs, as appropriate, by formalizing partnership structures and developing mutually beneficial, equity-focused relationships that bring real and tangible benefits to the Agency, CBOs, and Los Angeles region." The meeting held over Zoom was the first glimpse into a long journey of education and

preparation for a better and more cohesive strategy to better serve those in underserved and compromised positions, much like the work done on Metro's Blue Line which improved much of the programs delivery methods. For nearly two hours, several Metro staff workers who make up Metro's CBO Partnering Strategy team discussed possibilities while also laying out the purpose, goal, and pre-determined recommendations for the project.

Led by KeAndra Cylear-Dodds, Metro's executive office of Equity and Race, the meeting began with opening remarks as she welcomed each person and detailed exactly what Metro aims to fix. "The core objective is to increase access to opportunity for all and it recognizes that there are disparities that exist within our community that prevent full access for everyone, so our charge is really to understand and identify those disparities, and then come up with solutions that help

address and eliminate those disparities. And so that's, that's what we're working towards," Cylear-Dodds explained. She continued on to say one of the main pillars of focus, to listen and learn, is largely based on community engagement which fuels CBO partnerships and the reason for the virtual meeting.

According to CBO Partnering Strategy Draft, Metro added the Equity Platform Framework as a recognition of its influential role in Los Angeles and its duty to aid in reversing the disparities

Cylear-Dodds spoke of. The draft details the four project phases and was of which Metro builds and maintains successful partnerships. The draft then goes into depth detailing the seven recommendations developed and designed from both internal and external sources to ensure the goals of reaching across the entire agency.

The recommendations listed are to establish a central home for the CBO Partnering Strategy, develop and maintain a comprehensive CBO partner database, use criteria to determine the

compensation threshold, establish an internal library of resources and sample templates for CBO partnering, use a standard CBO partner chartering process, train Metro staff how to effectively partner with CBOs, and lastly, build CBOs' capacity to navigate and partner with Metro.

During the call, listeners were also able to add their additional hopes for recommendations to several Metro staff members including Ayda Safaei, director, Construction Relations and Mitigation Programs, Elizabeth Carvajal, senior director, and Michael Cortez, Community Relations manager. Many of the recommendations suggested and heard by the team revolved around community involvement, outreach, accessibility, and determining ways to identify programs and proposals that best fit the surrounding community.

"I am hopeful it's in the right direction, I know we really want to be able to compensate CBOs and bring

them to the table, especially on a lot of these opportunities in procurement," Cortez stated during the meeting. "Also training Metro staff on how to work with CBOs ... having Metro understand how to work with the different communities out there is also going to be critical and that's why we're advancing that in these recommendations."

Cylear-Dodds added in her remarks that clarity is going to be very necessary moving forward as well as acknowledgment of the needs of the community when thinking, building, and obtaining partnerships with CBOs. "I really look forward to figuring out how we improve upon this and how we continue to do all this work that's necessary to move us along in this to a more equitable Metro and processes," she continued.

Before closing, the group reassured that they would continue to hold virtual meetings to ensure that the strategy programs hit the mark.

Guest panelists include Relationship Coach—Christy Little Jones, Lifestyle Influencer—Deron Walker, Plant Based Nutritionist—Erica Nicholson, Lifestyle Influencer—Hadiatu Dumbuya, Entrepreneur—Johnathan Quarles, Generational Wealth Strategist—Jonelle Rocke, Travel Influencer—Josh Valentin, Travel Influencer—Julia

Menez, Holistic Health & Wellness Coach—Kena Hodges, and many more.

The online event launched with a warm welcome from Karisma Shackelford, with an audience of 100+ viewers streaming worldwide. Shackelford guided her audience through a 5-minute meditation. She recited positive affirmations that allowed everyone to sit back and enjoy the online workshops that offers solutions for empowerment through lifestyle change.

Shackelford eyes were closed as she took a deep breath and said, "I want all of you to sit back and allow your minds to be like a parachute and be open... Mother nature has taken her course. We are all blending and coming together to become a colorful world."

Generational wealth is an uncommonly discussed topic unless it is specifically searched for; however, the information presented in the generational wealth workshop was informative and inspirational. Sharing ideas of making sound economic decisions through the purpose of an everlasting family legacy.

Being the first speaker of the day, Generational Wealth Strategist, Jonelle Rocke gave a detailed PowerPoint presentation of what to consider when building and maintaining generational wealth. Rocke stated "70% of wealth that is passed down is lost in the second generation, and then over 90% is lost by the third generation. So, you have to put the work in now and prepare your beneficiaries."

According to Rocke, it takes a "wealth mindset," beliefs that spend time, resources, and energy on work that continues to pay off long after the effort has been invested. Rocke says, "If you fail to plan, you plan to fail. You have to give your money an assignment. If you do not tell it where to go, then guess what? It's going to disappear."

A strong sense of spirituality was at the core of each workshop, repeating phrases and affirmations like "I am a money magnet!" or "Unlock your personal power!" Each panelist acclaiming their success from practicing stern self-awareness and positive self-talk.

Lifestyle Influencer,

Hadiatu Dumbuya advised streamers to "acknowledge your imperfections as areas to grow." As well as "trying different learning tactics" like reading outside of formal education. Discussing one of his favorite 'easy to use' travel hacks; Travel Influencer, Josh Valentin mentioned "When you first get to the reception at any hotel, give [the recep-

tionist] a compliment and smile. Then when you are asking for your room, ask for an upgrade because there is that reciprocity between you and the person at the reception. A lot of time they will upgrade you complimentary because you were nice and gave them a compliment."

The online seminar culminated with Mechelle Lewis Freeman as she shared her experiences as a World-Class Olympian struggling with fear. By combating her fears with discipline, consistency, as well as visualizing short-term and long-term goals, she has found that the momentum of taking positive action silences the negative voices that live in each of our minds.

Freeman said, "Here I am, my first race back. I am like 'Okay, it's time to go!' I have been training hard, my faith is deep, and I'm still fast. I got it! The race goes off, and boom! I get dead last... So, now you have the mental part, and that's why consistency is so important. Now you know how to compete against that [fear]. So, when you feed that that faith and feed that vision, when

The company Webb created looks to “invest in human beings.” 4thMVMT focuses “on communities impacted by institutional racism.” Webb has an eye for people who have a dream of having their legacy, and uses that fire to ignite the process of bringing that vision to life.

4thMVMT envisions the future pathway for business. The creation of Webb’s company derived from the past; the birth of the company was conceived through the knowledge of initiatives of Martin Luther King Jr. They addressed the oppression, and socially constructed racism that continues to keep people of color in a second-class environment.

Webb credits 4thMVMT to the goals of Martin Luther King Jr. Webb stated, “King said, ‘if the experience of African Americans in the United States was described in the form of a symphony,

one of the greatest activists in history. 4thMVMT partners with individuals from underserved communities to endure the process of business ownership. He was enlightened by this platform, Webb concluded that the formula to successful business ventures consisted of funding, experience, relationships, and valued service.

As city commissioner, Webb highlighted the framework around relationships, “In any relationship, whether its employee/employer, personal, family, or the relationships between business and its customer—it’s about an equal exchange of value.”

With those components set in motion, social equity will be more than a dream passed down through the words of an activist. It will be present in physical existence among all communities. Webb acknowledges the matters of oppression that block the pathway for many people of color; keeping them from achieving their goal of ownership and better quality of life. 4thMVMT bypasses the obstacles of limitations in resources, and becomes a stream of wealth for anyone seeking a new financial course for their family line.

Webb found his way to be an activist, by uplifting the confidence of the collective community. Before unlocking his true nature in building empires for social equity, Webb assisted with generating PCF Restaurant Management, and became

batation Department. Webb also sits on the board of the Brotherhood Crusade.

As an uplifting member of the community, Webb was tapped by Los Angeles Mayor Eric Garcetti to be Commissioner of the City of Los Angeles Airport and Co-Chair of RENEW task force. The mayor reached out to Webb based on the reputation of growth that surrounds him. He shared a bit of the conversation he had with the mayor during the nomination period, Webb told Garcetti, “You might be nominating me for this position, but you got to know that I am about the equity first.” The mayor’s response was,

“That’s why I want you.”

In philanthropic efforts, Webb reflected on an event that put him on the pathway to a deeper understanding of his purpose. He said, “I taught an entrepreneurship class at Dorsy Highschool after I had opened the Buffalo Wild Wings on Crenshaw, and working with those young people I had an epiphany. Which was oh, I’m not in the chicken and beer, or sports bar business, I’m in the people development business.” Webb explained that opened his perception, and it commanded more energy out of him to push the agenda of social equity forward.

the first movement would be the abolition of slavery, the second would be civil rights, the third would be voting rights, and the fourth would be economic equality.”

When asked about the mindset needed to succeed in business, Webb said, “Have an idea about where you are going, and the best way to do that is to be clear about your quote-on-quote why—why did God put you on the planet.” He explained that a personal set of experiences indicates the destiny of oneself.

The 4thMVMT founder shared the understanding of goals begets the consistency needed in life to accomplish the set vision. Webb referred to this laser-beam focus as a personal “North Star,” that navigates the transformation of oneself.

Webb is a nourished seed, that took root in the spoken affirmation from

a franchisee of the beer and chicken eatery, Buffalo Wild Wings.

Working through a strategy of opulence, and being “best-in-class,” the current operating franchise location on Crenshaw is recognized for reaching the highest sales percentage (2012, 2013, and 2014).

The Buffalo Wild Wing franchisee gave credit to his staff and highlighting their interests, Webb said, “I call it exercising the muscle of excellence.” He painted the picture of all of one’s experiences point to the reason for their creation. Webb mentioned if one is open-minded during the process, one can see the skills that accumulate along the way.

see the potential in every person, Webb created an environment in his Buffalo Wild Wing franchise that surpasses other regional and national locations.



South Coast AQMD Governing Board Adopts Plans to Reduce Air Pollution in Southeast L.A. and Eastern Coachella Valley

Last Week, the South Coast Air Quality Management District (South Coast AQMD) Governing Board adopted two Community Emissions Reduction Plans (CERPs) identifying actions to reduce emissions and exposure to toxic air pollution in two environmental justice communities.

The communities of Eastern Coachella Valley (ECV) and Southeast Los Angeles (SELA) were designated for the second year of the community air program established by Assembly Bill 617 (C. Garcia), which requires local air districts to reduce the disproportionate impacts of air pollution in environmental justice communities.

"We have worked tirelessly over the past two years to better understand the air quality concerns

within these two communities," said Ben Benoit, South Coast AQMD's Vice-Chair. "Today's Board action allows us to continue this process so that when finalized, these plans can provide both short and long-term emissions reductions that can have lasting impacts to the health of those who live and work within these communities."

The CERPs include air quality priorities identified by the Community Steering Committees (CSCs), which consist of members of the public who live, work or go to school within each community, including active residents, community leaders, local business owners or workers, community organizations, local agencies, schools, universities, hospitals, tribal organizations and elected officials.

The plans include specific actions that go beyond existing efforts by South Coast AQMD, to reduce air

pollution emissions and/or exposures, including efforts to conduct community air monitoring, focused enforcement and outreach in these communities.

Eastern Coachella Valley CERP: Aims to reduce air pollution from the Salton Sea, pesticides, fugitive road dust, the Greenleaf Desert View Power Plant, diesel mobile sources, open burning and illegal dumping. Specific actions include:

- Reducing emissions by paving unpaved roads;
- Establishing a notification system for permitted agricultural burning;
- Working with scientists at public health agencies with expertise in pesticide toxicity to identify key pesticides of concern for air monitoring;
- Expanding the monitoring network to address concerns about H2S and PM emissions from the Salton Sea, agricultural

pesticide use, open burning and fugitive road dust through collaboration with various entities;

- Installing air filtration systems in schools, homes and community centers near sources of air pollution; and

- Incentivizing the replacement of older, higher polluting on-road and off-road equipment with cleaner technology.

Southeast Los Angeles CERP: Aims to reduce pollution from stationary and mobile sources; and make reducing community exposure to air pollution a top priority. Specific action targets include:

- Reducing pollution from trucks such as prioritizing incentives for zero-emission replacements;
- preventing truck idling via outreach and enforcement;
- encouraging a clean truck lane on the 710 freeway;

identifying and reducing emissions from metal processing, rendering and other industrial facilities;

- conducting air monitoring near railyards; and
- increasing green spaces.

To develop the CERPs, South Coast AQMD held a total of 116 public and individual meetings with ECV and SELA CSC's to identify and prioritize emission reduction actions and discuss community air monitoring plans.

This year provided challenges of tight schedules due to AB 617 statutory requirements with time lost due to transitioning to a virtual format due to COVID-19. South Coast AQMD will continue to work with the ECV CSC to further develop the CERP and return to the Governing Board by mid-2021 for approval of the revised plan, which will then be submitted to the California

Air Resources Board (CARB) for final approval. Following CARB's approval, implementation will take place over approximately five years.

Under the first year of the AB 617 program, South Coast AQMD led community steering committees in Wilmington/West Long Beach/Carson, San Bernardino/Muscoy and Boyle Heights/East Los Angeles/West Commerce. CERPs for these communities were approved by CARB in September 2020.

want to walk into the store and get helped, and others are very happy to visit and do business online. I think both during this time is very important.

(LAS): What are some grants/loans that a small business should be taking advantage of right now?

(K): The one good thing that has come out of the COVID-19 pandemic is that you do have a number of programs out there. You have a number of corporations who are standing up and saying, 'Let's support small businesses!' So, I

encourage small businesses to go to the different websites like Amazon.com or Facebook.com. You have a lot of corporations who have put initiatives in place to support small businesses. I think those are things that small businesses have to look for. You also have a number of cities that are doing programs that also provide some sort of grant or relief. Now, I am going to tell you that it is not significant enough to keep your business operating, but it's a little bit of help along the way. You can do a search to

find these different programs, they are available more than I've ever seen in the past. You [also] have business development centers that are doing informational meetings to update you on the latest.

(LAS): Can you give me some common mistakes small business are making right now, and how should they be avoided?

(K): I would say not being innovative. This is a time where you have got to get as creative as possible. You have got to talk to people around you, find out

what the problems are, what the needs are, and quickly present a solution. Then I would say being willing to pivot. As a business owner, you have got to figure out how to pivot as a company into what could be a new way of doing business. So, I think businesses that stand there and watch, it's definitely a mistake.

(LAS): You mention creativity and innovation, if you were starting a business right now, how would you be innovative and creative?

(K): I'm glad you asked that! One of the things I


Brotherhood Crusade's Annual Navidad en el Barrio Brings the Spirit of Giving

COVID-19 Vaccine Arrives as Surge Continues to Overwhelm Hospitals

As the COVID-19 vaccine is distributed to specific locations, the surge continues to rise with a rising number of healthcare workers getting infected.

"I want to thank the many people who made today possible starting with the scientists and researchers who have shown incredible diligence and ingenuity under the most pressing circumstances, the volunteers who participated in the clinical trials, the production teams who found ways to quickly manufacture this life-saving vaccine, and the transportation teams who have managed the crucial work of getting the vaccine to facilities across the country so that vaccinations can begin immediately," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health.

She continued, "And to all the public health practitioners at federal, state, and local health departments, thank you for the 24/7 work to ensure the safe and equitable distribution of this vac-

cine across every community. Because it is likely to take a few months to have enough vaccine available to immunize the millions of individuals who live and work in L.A. County, in the meantime, we all must continue to remain extremely diligent in reducing transmission of the virus."

Los Angeles County, like most across the nation, are in a holding pattern as they wait for the COVID-19 vaccine. According to the L.A. County Department of Public Health website, 9 shipments of the vaccine arrived Monday and were distributed amongst pre-positioned sites. It was stated the initial allocation of the vaccine in L.A. County is 82,875 doses with two additional allocations expected with the month. This does not include allocations for the cities of Long Beach and Pasadena, which have their own independent health departments and are

receiving their own allocations.

Those nine prepositioned locations are working with the L.A. County Dept. of Public Health and EMS to deliver the vaccine to acute care hospitals that serves COVID-19 patients. Public Health has hosted webinars, held office hours, and is distributing information to prepare acute care hospitals for the large endeavor ahead. A second allocation of the vaccine will arrive later in the month for a distribution to all health care personnel and residents at nursing facilities, along with continued distribution to frontline healthcare and EMS personnel.

As of Monday, December 14, the L.A. County Dept. of Public Health confirmed 48 new deaths and 7,344 new cases of COVID-19. There were 4,203 people with COVID-19 hospitalized with 21% of these peo-

ple in the ICU. Since the beginning of the surge in November, cases have increased 625% with younger people being the largest source of transmission in the county. More than 70% of cases are from people under the age of 50-years-old. Residents over 80-years-old have the highest rates of hospitalization among all age groups in L.A. County followed by residents 65 to 79-years-old,

and residents 50 to 64-years-old.

Due to the recent surge in cases, there has been an increase in cases among healthcare workers. Over the last two weeks, it's been reported there are 3,400 new cases among healthcare workers. In early November, it was stated there were 40 new cases among healthcare workers a day; last week there were nearly 250 cases among healthcare workers a day.

As of Monday, December 14, Public Health identified 532,730 positive cases of COVID-19 across all areas of L.A. County and a total of 8,345 deaths.

Laboratory confirmed total cases show 532,730 with Los Angeles County showing 507,226 cases, Long Beach with 20,697 cases and Pasadena with 4,807. By race and ethnicity, COVID-19 statistics show: American Indian/Alaska Native with

740; Asian with 17,475; Black with 15,834; Hispanic/Latino with 207,749; Native Hawaiian/Pacific Islander with 1,682; White with 47,630; those of other race and ethnicity with 51,058 and 165,058 under investigation.

Dr. Ferrer had this to share about the recent surge of COVID-19 and residents who refuse to comply with the temporary restrictions, "We continue to see extremely high numbers of new cases, hospitalizations and deaths from COVID-19 - the surge we are experiencing is alarming. If you are not playing by the rules, to be blunt, you are part of the problem, and at this point, you are contributing to these distressing increases in cases, hospitalizations, and deaths."

Cal Safety Workgroup Endorses COVID Vaccine Ahead of National Rollout This Week

With concerns still lingering about the safety and side effects, the Pfizer/BioNTech COVID-19 vaccine has passed the full approval process and it is ready for distribution in the U.S. The first doses will arrive at California hospitals this week.

On Dec. 11, the U.S. Food and Drug Administration (FDA) issued an emergency use authorization for the Pfizer/BioNTech coronavirus vaccine to be distributed to individuals 16 and older. In a statement, the FDA said that Pfizer's clinical trial data showed that the "known and potential" benefits of the vaccine outweighed its risks.

"Today's action follows an open and transparent review process that included input from independent scientific and public health experts and a thorough evaluation by the agency's career scientists to ensure this vaccine met FDA's rigorous, scientific standards for safety, effectiveness, and manufacturing quality needed to support emergency use authorization," said FDA Commissioner Stephen M. Hahn, M.D.

On Dec. 12, U.S. Centers for Disease Control and Prevention (CDC) Advisory Committee on Immunization Practices recommended the

Pfizer vaccine. CDC Director Robert Redfield, M.D., accepted the recommendation on Dec. 13, passing the vaccine through the final step needed for distribution. On

the same day it received CDC approval, the first batch of vaccines was shipped out of a Pfizer plant in Portage, Michigan.

"This is the next step in our efforts to protect Americans, reduce the impact of the Covid-19 pandemic, and help restore some normalcy to our lives and our country," Dr. Redfield said in a statement.

In addition to governmental reviews, state officials and public health organizations are also reviewing the safety of the Pfizer vaccine. The Western States Scientific Safety Review Workgroup, made up of scientists and experts representing California and other states, independently reviewed and endorsed the vaccine's safety on Dec. 13.

"This morning, the Workgroup recommended the Pfizer vaccine as safe for

public use. With shipments of the vaccine soon on their way to California, we are working hand-in-hand with local public health officials to get the vaccine out to the first

tered 21 days apart. FDA documents note that the vaccine seems to provide "some protection" after the first shot, but it takes both doses to reach an efficacy of 95 %.

Once the vaccines arrive in California, they will be sent to hospitals and other facilities that can store them at around minus 94 degrees Fahrenheit. Storage facilities confirmed so far include Cedars-Sinai Medical Center and UC San Francisco Medical Center.

Priority for receiving the vaccine will go to health workers most likely to be exposed to COVID-19, as well as residents and staff of nursing homes and long-term

care facilities. According to public health experts, vaccines will most likely be available for the general public in spring or summer 2021.

As of Sunday night, the COVID-19 death toll in the United States since the pandemic was declared in March reached nearly 300,000. An estimated 16.2 million Americans have been infected. In California, there have been an estimated 21,043 deaths and 1.5 million reported cases.

According to FDA documents, the vaccine does have some common adverse effects, including pain at the injection site, fatigue, headache, chills, muscle or

joint pain and fever. Long term effects of the vaccine are not yet known.

The FDA has also warned against using the Pfizer vaccine for people who have had severe allergic reactions to ingredients used in this vaccine. Though severe allergic reactions to vaccines are rare, some participants in the Pfizer trial did experience adverse reactions, and the trial itself excluded people with a history of the severe allergic reaction anaphylaxis.

In a Dec. 12 press conference, the FDA said it will continue to monitor severe allergic reactions associated with the vaccine.

Concerning Kwanzaa, Race and Religion: Particular, Universal and Common Ground

This is a revisiting of an early and ongoing conversation about the shared meaning of Kwanzaa, its particular cultural message to African people, and its core values that speak to the best of what it means to be African and human in the world and for the world. It raises the constantly relevant issues of race and religion and how they relate, not only to Kwanzaa as a holiday, but also to us as a people.

Each year the coming of Kwanzaa brings a sense of joyful satisfaction of having created something unique, beautiful, and beneficial for our people. It also reminds me of the extensive and enjoyable research, study and thought pursued to conceive and create Kwanzaa, and the overall and ongoing labor of love offered to make Kwanzaa a living, lasting and transformative tradition worthy of the name, history, and culture African. As an activist-scholar, I sought to build into Kwanzaa's Kawaida philosophical framework answers to questions that would be raised, not only about the daily practice and values of Kwanzaa, but also about its origins and intent, its relation to religious and other holidays, and our self-conscious insistence on the special and particular meaning and message it has for us as African people.

I think too of how millions of African people all over the world have embraced and celebrate this pan-African holiday Kwanzaa and how Kwanzaa unites us in ways no other holiday does. And I think of how it reaffirms our identity, dignity and excellence as African people, grounds us in our culture and pro-

vides us with a value system in the Nguzo Saba (The Seven Principles) which serves as framework and foundation for our internal strengthening and flourishing and our bringing good into the world. These are Umoja (Unity), Kujichagulia (Self-Determination), Ujima (Collective Work and Responsibility), Ujamaa (Cooperative Economics), Nia (Purpose), Kuumba (Creativity), and Imani (Faith).

Given the phenomenal growth and solid grounding Kwanzaa has achieved in the world African community, it's no wonder claimants and controversies rise around it. Indeed, if it had remained a small organizational holiday as in its first years, no one would think it worthy of either claim or comment. For success always has numerous fraudulent fathers and pretentious mothers, but failure is almost always an orphan. Thus, there is an increasing parade of pretentious contributors to Kwanzaa's conception, revisionist "histories" claiming discoveries of new authors and collective origins of its creation, and a persistent stream of right-wing, left-wing and liberal criticism around contrived issues of race and religion.

The first problem of quaint and curious claims of creating Kwanzaa is easily solved by testing the claimants for evidence of competence in African cultures and languages relevant to the conception of Kwanzaa, for indications of relevant research and associated intellectual activity, and for demonstration of continued contribution beyond anecdotal references and imagined assistance in wishful ways. The second

reconception and misrepresentation of Kwanzaa poses a more serious problem. For it seeks to interrupt Kwanzaa's continuing expansion, undermine its acceptance, and question and deny the right of Black people to celebrate themselves, embrace their own culture and have their own holiday without needing to explain away themselves or deny the special and particular meaning the holiday holds for them. And the criticism is posed in racial and religious terms to appeal to emotion and render reason almost irrelevant.

The issues of race and racism are raised around the strange and confused contention that Kwanzaa is too Black and we are being too Black by insisting on its Africanness, its Blackness and its particular meaning for Black people. Moreover, it is asserted that Kwanzaa and Black people must be less Black, if we are to be accepted and acceptable in the dominant society. Now, it should be noted that there is no public parallel conversation like this for others; no calls for Jews or Hanukkah to be less Jewish, or for the Irish and St. Patrick's Day to be less Irish. Indeed, no other people are criticized for being too much of themselves or called separatist for having and celebrating a holiday that has a special and particular message and meaning for them, regardless of its meaning to others.

Yet there is among some a racial uncomfortableness about Black and Kwanzaa and thus, attempts to discredit it or redefine it to make it socially "accept-

able" like with King and Malcolm. One such attempt is to redefine and re-present Kwanzaa and them as universal and not particular to Africans, as if we can't be both. Indeed, Kwanzaa is culturally particular, but its essential message is both culturally particular and universal in the human sense of the word. To say that it is culturally particular is to say that it is culturally rooted, rises out of a particular people's history and culture, bears the imprint and content of that people's ideas and values, and speaks to the people in a special and particularly meaningful way. Therefore, Cinco de Mayo speaks to Mexicans in a particularly meaningful way; Chinese New Year to Chinese; Hanukkah to Jews; and St. Patrick's Day to the Irish. And no one asks these cultural groups to redefine their holidays to de-emphasize their origins, make them less Mexican, Chinese, Jewish or Irish or redefine them so that they lose their particular historical and cultural meaning. And likewise, no one should ask that Kwanzaa be redefined and adulterated in such ways.

Kwanzaa is, of necessity, an African American and pan-African holiday and requires no permission or external acceptance for its practice, profound meaning or worth. Nor can it deny its special and particular meaning to African people without undermining its essential message and meaning as a celebration of African family, community and culture and a unique contribution to the diverse richness of human life and culture. And because Kwanzaa builds on the best of African culture, its message, like all ethically-expansive and world-encompassing messages, has both a particular and universal meaning. It speaks first and foremost to us, originates from us and is an expression of the special cultural truth we speak to the world. And in this, it speaks not only to the best of what means to be African, but also the best of what it means to be human and thus offers a common-ground message to other humans in the world.

Therefore, religious resistance to Kwanzaa is also misplaced and is provoked and promoted by manipulation of uninformed apprehension and misunderstanding. There is no Kwanzaa competition or conflict with the various religions Black people embrace, for as we've said for years, Kwanzaa is a cultural holiday not a religious one. Kwanzaa builds on the best of African tradition and opens up cultural space for Africans of all faiths. And thus, Africans of all faiths can and do celebrate Kwanzaa: Black

Christians, Muslims, Hebrews, Jews, Buddhists, Bahá'í, and Hindus, as well as those who follow the ancient African spiritual and ethical traditions of Maat, Ifa, Ashanti, Dogon, etc. For Kwanzaa offers is not an alternative to their particular religions or faiths, but a common ground of African culture which they all share and on which they meet and are reaffirmed in the expansive meaning and sacred beauty of their being African in the world.

Thus, all over the world, African people rightfully celebrate Kwanzaa, embrace and find common ground in its cultural and ethical values, in its insistence on the oneness and sacredness of life, social justice, due respect of persons and people, responsibility and care for the vulnerable, repair and preservation of the environment, the end of oppression everywhere, a just peace, and the shared obligation to constantly bring and sustain good in the world through righteous and relentless struggle.

I disinfect the rooms of COVID patients at Kaiser, We urgently need a hero bonus to recognize and retain staff

I've worked at Kaiser Los Angeles Medical Center for 37 years in the environmental services department, where we're responsible for cleaning and disinfecting the hospital. Although environmental service workers aren't always the most visible members of the healthcare delivery team, we're absolutely essential for infection control, especially during this global pandemic. We take deep pride in our work, but we're struggling during this vicious third COVID wave as many of our coworkers have been infected. We need Kaiser executives to give back to

their workforce in order to recognize and retain staff, so we can ensure safe care for our patients.

Sanitizing COVID patients' rooms is very difficult, detailed and dangerous work. After they are discharged or pass away, we have to scrub the walls and other surfaces, clean the beds, and even wipe down the vents using powerful chemicals to make sure every room is completely

sterilized. In my department, we've had five coworkers who've gotten sick from COVID since the pandemic began. Some Kaiser workers have made

the ultimate sacrifice with their lives.

Because we're so understaffed and overwhelmed

with patients, I've sometimes worked three shifts in a row, 24 hours straight in order to get all the work done. Healthcare workers throughout Kaiser have dedicated our lives to quality patient care, but we're wrestling

with nerve-racking fears and anxieties about the health of ourselves and our loved ones. I'm worried every day about bringing the virus home to my mother who is 79-years-old and blind. It would crush my heart if I ever inadvertently caused her harm.

Destination Watts, Then And Now

Watts is a historic place. It's where oppressed people from the Deep South and, more recently, from around the world, have come to start a new life in fabled California. They fled the remnants of slavery, Jim Crow, the Klu Klux Klan, lynchings, and corrupt political and legal systems. They fled oppression and political exclusion and came with great hope in search of a new life.

While better than the lands they fled, Watts was far from paradise. Until the mid-1900's, the Klan was in Watts too and segregation and political exclusion were political norms in Los Angeles. It has always been rough in Watts but a community managed to take hold and was proud of its new struggling place in the sun. People established roots and took pride in Watts. They fought political battles to make Watts a better place and a place they proudly called home. They lived and died there, buried their loved ones nearby. They stayed and tried, and tried very hard, to be treated with respect and dignity.

Although Watts has been very much like an

abused stepchild of Los Angeles since its annexation in 1926, it has managed to achieve international fame because of its history, cultural icons, as well as being the site of the largest urban uprising in American history in 1965 when residents violently resisted political and economic abuse by the City of Los Angeles.

Watts itself is a monument to the great universal struggle for civil rights and to the hope for a better country and a better world. It should not be dismantled piecemeal by those who did not build it, those who have not lived it, and by those driven by self-interest. For example, Watts does not need more so-called "affordable housing" structures which would line the pockets of Westside developers and their political friends. It is already the most densely populated, most impoverished, and most contaminated section of Los Angeles. It doesn't want and doesn't need housing built and owned by outsiders which will inevitably transform, undermine, and destroy the legacy of Watts.

Instead, Watts could

and should become a world-class tourist attraction, a living monument to all people seeking to overcome oppression whether it be political, economic, or racial. Imagine a transformed Watts with main streets renamed Emancipation, Thurgood Marshall, Rosa Parks Boulevards, Lillian Mobley, Caffie Green, Cesar Chavez, Charles R. Drew, Kobe Bryant, Jackie Joyner, Muhammad Ali, Malcolm X, Maria Elena Durazo and hundreds more, there are so many more heroes than streets. You get the idea.

And, all of those newly-named boulevards and avenues lined with gas lamps, ethnic restaurants, clubs, music venues, all owned by and employing locals.... safe for tourists and locals alike. And, of course, all of these newly-named streets and boulevards converging on the long-promised Cultural Crescent, a grand complex consisting of the historic train station, museums, and other monuments to the remarkable tenacity of the people of Watts and their struggle for an equal place in the sun.

The Cultural Crescent has been a repeatedly-

promised development during uprisings and protests for over the 55 years. The community has been planning for it and waiting for it. The time has now come to keep that long-overdue promise. Doing so will be transformative. Tourists will come in droves to Watts, to enjoy the food and entertainment, and to learn of a community's struggle for fairness and equality which mirrors our nation's struggle to right past wrongs. It will be an inspiration for people everywhere who are hoping for and struggling for a better life.

Just think of it...

Destination Watts! This is what Watts could be and should be. A place where people go for inspiration and go to experience an authentic culture. This is the dream of Simon Rodia when he was building the world-famous Watts Towers and it has been the dream of other local giants. The dream cannot die.

Among other things, Watts is a central transportation hub linking together all parts of the city and county and deserves access to right-of-way revenue that has always been diverted elsewhere.

Watts could easily make a powerful argument for cityhood. Yet, Watts should, if possible, remain

part of Los Angeles instead of becoming separately

incorporated. Nonetheless, all options should be on the table in the political confrontations that may present themselves in the fight for a just future. Politicians should be listening to the growing sounds of justice and equality. Watts must have its fair share of political power and public resources.

Watts must not allow concealed forces of destruction, disguised in the name of urban development, progress, affordable housing, or anything else that would destroy the dream of Watts; a place that deserves to be preserved as a national memorial to oppressed people everywhere and to those who continue to fight for a just and fair society. It's time

to accelerate our fight and call for meetings to set the agenda. We need to stand together and be counted in order to continue the fight that so many others before us fought.

Georgia and its long history of voter suppression

Now that Donald Trump's baseless lies about voter fraud have been summarily dismissed by the courts, perhaps some attention can be paid to the true threat to free and fair elections: systemic and massive voter suppression.

Voter suppression, not voter fraud, could have critically important effects in Senate runoff elections in Georgia that will determine which party controls the majority in the U.S. Senate.


In Georgia, voting rights groups, including the Rainbow PUSH Coalition and the Black Votes Matter Fund, have filed a lawsuit challenging the wrongful purge of nearly 200,000 voters from the voting rolls over the last two years. They are seeking, with the aid of counsel provided by the National Bar Association, injunctive relief to reinstate these voters prior to the Jan. 5 Senate runoff races.

As a September report

from the Georgia American Civil Liberties Union states, the voters purged are likely to be "young voters, voters of lower income and citizens of racial groups that have been denied their sacred right to vote in the past."

With Republicans in control of the state, it isn't surprising that these are voters who are likely to vote overwhelmingly for Democrats. Nor is it surprising that the state chose not to use a licensee of the U.S. Postal Service — as required by law — to carry out the mailing designed to confirm that the voters were no longer at the address. Instead, it was done by a one-person firm located in Nebraska.

An independent analysis of over 300,000 voters purged from the rolls after 2018 showed that over 60% wrongfully lost their right to vote because of an incorrect assumption that they had changed their address. Too often, these voters never discover they

have been purged until the time to vote, when it is too late.

The ACLU and Greg Palast, the independent investigator who discovered the wrongful purges, tried repeatedly to get the Georgia secretary of state to agree to meet to review the proof of unjustified purges. After receiving no reply, voting rights groups decided they

had no choice but to file the lawsuit.

Georgia has a long history of voter suppression, dating back to the post-Civil War period when the Ku Klux Klan used widespread violence to intimidate Black and Republican voters in order to re-establish white supremacy. Georgia was one of the states that perfected Jim Crow laws to limit Black votes. Now, as Rev. William Barber II notes, "Jim Crow did not retire; he went to law school and launched a second career. Meet James Crow, Esquire."

Georgia has employed all of the modern techniques of voter suppression. It has closed polling places disproportionately in areas of Black concentration, forcing voters to wait in lines for hours to cast a vote. It has repeatedly purged the voting rolls, striking far more voters off than the average state across the country. It required "exact match"

voter signatures on registrations, with up to 80% of those disqualified people of color (a lawsuit brought that ploy largely to an end in 2019). When Republicans assumed total control of the state in 2010, the resulting gerrymandering was, as Rep. John Lewis stated, "an affront to the spirit and the letter of the Voting Rights Act."

What has been happening in Georgia has been happening in states under Republican control across the country. Increasingly a minority party in a diverse and young nation, Republicans have been perfecting ways to gain power without capturing a majority of the votes.

In Georgia, a hearing on the lawsuit — backed by a record of independent and authoritative expert analysis of the voters purged from the rolls — was slated for Dec. 10. Hopefully, this injustice can be corrected before the runoff in January.

Donald Trump's false

claims about voter fraud have captured the front pages and immediate attention of courts across the land. Ironically, the authoritative challenge to brazen voter suppression has received far less attention.

In Georgia and elsewhere, it will take constant attention, citizen mobilization and litigation to challenge the increasingly sophisticated efforts to suppress the vote.

Greater Los Angeles VA Begins COVID-19 Vaccinations

The VA Greater Los Angeles Healthcare System (VAGLAHS) began administering COVID-19 vaccinations to frontline health care employees and Veterans residing in long-term care Community Living and Spinal Cord Injury and Disorder centers today.

VAGLAHS is part of the initial group of 37 VA medical centers across the country that began receiving and administering the Pfizer-BioNTech COVID-19 vaccine this week.

The sites were chosen for their ability to vaccinate large numbers of people and store the vaccines at extremely cold temperatures.



"The Greater Los Angeles VA Healthcare System is proud to be a part of the initial 37 VA medical centers receiving the vaccine," said Steven E. Braverman, M.D., Director, VAGLAHS. "We are dedicated to ensuring all Veterans receiving care at VA and our employees are ultimately offered the vaccine."

The U.S. Food and Drug Administration stated that in clinical trials the Pfizer-BioNTech COVID-19 vaccine was 95% effective in preventing COVID-19 disease. The vaccine is administered as a series of 2 doses, 21 days apart. The side effects appear similar to those of other vaccines and are short-lived.

COVID-19 vaccine



implementation will include an initial limited-supply phase followed by a general implementation phase, when large sup-

plies of the vaccine will be available.

As increased vaccine supply becomes available, VA plans to distrib-

ute these vaccines at additional facilities to offer the vaccine to more Veterans and employees.

VA will report directly to the CDC data on all vaccine doses administered by VA. The department will also provide general, public updates on the number of people who receive the vaccination at these sites, similar to how VA posts COVID-19 testing figures.



both Senator Bradford and Assembly Member Jones-Sawyer take on the challenges of police reform, prison guard standards and their modes of operation.

Jones-Sawyer released a statement thanking Assembly Speaker Anthony Ren-

don and Senate President pro Tempore Atkins “for recognizing that in order to meet this moment amidst the outcry for criminal justice reform, voices from over-policed communities must be elevated to lead all Californians forward.” Sen-

ator Bradford and Assembly member Jones-Sawyer both represent districts with constituents desperate for reform and positive change in our criminal justice system. Their efforts over the years have been focused on introducing legislation that em-

phasizes rehabilitation and education over incarceration, the closing of private prisons, and establishing a police culture of transparency and interaction with local communities.

“The role as Public Safety chair will be chal-

lenging especially in light of all we are facing as a state and nation, but I welcome the opportunity to provide substantial changes and improvement to the system,” said Senator Bradford. “As Chair, I will work toward improving the safety of our residents, offering justice to victims of crimes, passing true criminal and judicial justice reform measures that hold those in authority accountable for their actions, increasing transparency between communities and their officers, cultivating a real system for rehabilitation and actively supporting the formerly incarcerated. The recent reporting that California’s police agencies have upheld less than 2% of racial profiling complaints demonstrates that reform is desperately needed. Californians are counting on us to pass meaningful and comprehensive reform, such as SB 2, which the Pro Tem and I introduced last week to decertify bad officers. I will not be able to accomplish these efforts alone,

but by working collaboratively with my fellow committee members, law enforcement, community organizations, advocate groups, and all Californians.”

The two legislatures and their respective committees are poised to take on progressive policies aimed at transformational reforms in public safety. The goal is to help modernize and create exemplary officers in state and local departments. Their commitment remains to ensure public safety is consistent with California’s values of equity, fairness, and justice.

Other members serving on the Senate Public Safety Committee are: Senator Rosilicie Ochoa Bogh (R-Yucaipa) as Vice Chair, and Senators Nancy Skinner (D-Berkeley) and Scott Wiener (D-San Francisco).

Force Indy Aims to get More African Americans in Motorsports

Business leader Rod Reid is using his passion for motorsports and experience with being a road manager to create the Force Indy race team. The team is set to compete in the 2021 Copper Tires USF2000 Championship.

The USF2000 will last from February to August, with competitions in Canada and several states including Florida, Alabama, and Indiana. Force Indy will compete in its' inaugural race at the Firestone Grand Prix of St. Petersburg on March 5-7, 2021.

Reid has been around motorsports for many years. Back in 1984, he was manager of Scorpion Racing; the team began racing in Laguna Seca in California.

"We were running a class that was called Super-Vee," Reid said. "That was an open wheel racing class."

Reid will make an emphasis on hiring African

Americans for Force Indy as staffers, engineers, mechanics, and drivers. He also wants to help them have a thriving career in Motorsports; Force Indy will also provide a mentorship with Team Penske.

"When the IMS and INDYCAR acquisition happened a year ago, I was pleased to learn of the work Rod Reid was doing," Indianapolis Motor Speedway Chairman Roger Penske said. "Together, we'll work to not only get this new team off the ground but continue to support it and its mission as it continues down a path to compete at the top level."

Because of the mentorship, Force Indy will be located in Concord, North Carolina for its' first season. Team Penske has won 16 NTT INDYCAR SERIES and 18 Indianapolis 500 championships. Reid mentioned how the expertise and help from Team Penske is invaluable.

"To get mentored by the best it's certainly important," Reid said. "That's

common in racing ... when they build a race team and you try to find folks that can give you support."

Force Indy will have No. 99 on their car to honor the legacy of Dewey "Rajo Jack" Gatson. Gatson was one of the first African American racers in America, he competed during the 1930s and 1940s. He won several races throughout the West Coast.

In 2003, Gatson was inducted in the West Coast Stock Car Hall of Fame. He was also inducted into the National Sprint Car Hall of Fame in 2007.

In 2000, Reid and his partner Charles Wilson created the Nexgeneracers program which helped teach youth from 11-15 about Indy racing. The program ran under the non-profit organization NXG Youth

Motorsports Inc. Nexgeneracers was created to teach youth how to race and how to advance in a motorsports career.

"We bought go carts and we would provide all the assets, all the equipment that kids would need," Reid said. "NXG Youth Motorsports has had over 2000 kids in the program in those 14 seasons."

In a program that con-

sists of five different levels, youth learned life skills and STEM lessons through Nexgeneracers.

"We'll compare what it's like to traverse and to try to drive on a road course, compare that to driving in your own life," Reid said. "We will compare everything from tire pressure to atmospheric pressure in our lives to peer pressure that you may have as a child."

Youth also learn about financial literacy and how to operate tools. On every class level, the students learn how to drive and they get into competitive racing at the fifth level.

Force Indy is part of the "Race for Equality and Change" initiative that INDYCAR and Indianapolis Motor Speedway have.

"They were gonna put dollars and efforts behind programs like our program," Reid said. "My biggest concern was it wasn't a hollow program, that it's really genuine that they would stand behind it and Roger Penke certainly has done that."

Clippers Add Skillful Youth and Experienced Veterans on Roster

The Los Angeles Clippers are going into the 2020-2021 season with an upgraded roster and with thoughts of their second-round 2020 Playoffs exit behind them.

On December 10, forward Paul George signed a four-year \$176 million deal with the Clippers. Last season George played in 48 games, scoring 21.5 points and 5.7 rebounds per game. In the Playoffs, George scored 20.1 points and 6.1 rebounds per game.

George mentioned how he wants to build a foundation with the Clippers and playing for them is a childhood dream come true.

"I love being here, I love the family that I created in my first year," George said. "It's a priceless deal to me, having the opportunity to play here and be in front of my family, my friends and leaving my mark."

In making his decision, he notified forward Kawhi Leonard with the hope that he will stay in the future.



During his career, forward Paul George has scored 20.0 points and 6.4 rebounds per game.

Leonard can opt out of his current contract with the Clippers at the end of the 2021 season to become a free agent.

Last month, center Serge Ibaka signed with the Clippers in a two-year deal for \$18.9 million. Ibaka spent the last four years

preseason game, he scored six points after playing for 15 minutes against the Lakers. Lue applauded his ability to rebound in his preseason debut.

"That's something I definitely think I can do is taking up space, rebounding, getting up for blocking

NFL Executives on Diversity: 'We've Got to Do Better'

Ron Rivera of the Washington Football Team was the only minority head coach hired in the NFL heading into the 2020 season and, to the highest-ranking African American in the sport, that's unacceptable.

"When you look at mobility of Black men and Black women in professional sports, it's poor," said Troy Vincent, the league's executive vice president of football operations. The only person in a higher post in the NFL is Commissioner Roger Goodell.

"The facts are the facts, none of the sports leagues

are doing well," Vincent noted on a conference call with journalists, including the Black Press.

"We have done a thorough examination of what we're doing wrong, what doesn't work. But there are no best practices in sports," Vincent declared.

"Let's be straight. Let's be honest. We can go to every sport from basketball, hockey, baseball, here: Diversity, we do not see what we all hope for. We do not see true inclusion."

The league announced earlier this year that it had enhanced its Rooney Rule.

This policy requires teams to interview ethnic-minority candidates for head coaching and senior football operation jobs.

The expanded rule requires teams to interview at least two external minority candidates for head coaching openings and at least one minority candidate for any coordinator job.

Additionally, teams

must interview one external minority candidate for senior football operations and general manager jobs.

Clubs and the NFL league office must also include minorities and female applicants for sen-

ior-level positions, including club president jobs.

"It goes without saying that we have to do things differently," said Dasha Smith, the NFL's Executive Vice President and Chief Administrative Officer. "We are hopeful we will see different outcomes at the end of this GM and coach hiring season."

There currently are four minority head coaches in the NFL, including Rivera, Mike Tomlin of the Pittsburgh Steelers, Brian Flores of the Miami Dolphins, and Anthony Lynn of the Los Angeles Chargers.

Just two of the 32 teams have African American general managers - Chris Grier of the Dolphins and Andrew Berry of the Cleveland

Browns.

"We're a month away from 2021. And we're still talking about women in senior-level positions? In coaching positions? Come on. Gimme a break," Vincent demanded.

"These young men and women today in high school and college, they're used to seeing women in leadership positions. And they pause because they get to this level? The closer you get to the playing field, the least opportunities there are for women? Come on.

"We've got to look at ourselves and be frank and call truth. Facts and data do not support where we are across the entire sports industry. So, we've got a lot of work to do."





The Work of Women Empowerment Found Behind New Novel, 'Through My Mother's Eyes'



Johnson stated, "As a first-time author, I had no set limitations or rules on how this book was going to be published, only one






Iconic Actor and Noted Athlete Tommy "Deebo" Lister, Found Dead in Marina Del Rey Residence

Known for his iconic character "Deebo" in the Cube Vision production series "Friday" Tommy Lister died on Thursday, December 10, 2020. Lister lived a colorful life, crossing entertainment lines as a pro-wrestler to a noted actor, the 275-pound performing artist was known as the "Gentle Giant," to all his fans and loved ones.

According to reports by TMZ, there was a release from the L.A. County Sheriff's Department as his friends and family began to grow worrisome after not hearing from Lister since Wednesday night.

Law enforcement completed a "welfare check" at his home located in Marina Del Rey. Cops showed up in the 4100 block area where Lister lived and found him unconscious in his apartment. With current information, Lister at age 62 was pronounced dead at

the scene, more information should come to light when the official autopsy is performed.

Also known as "Tiny," Lister was showing symptoms of COVID-19 in the days leading up to his sudden death. Feeling unwell, the actor canceled showing up on-set for an unknown production. Lister wasn't transferred to the hospital to be revived.

Learning about the tragic news, the creator of the movie series "Friday," "Next Friday," and "Friday After Next," hip-hop icon and executive producer Ice Cube posted his respects on Twitter. Ice Cube tweeted, "...America's favorite bully was a born entertainer who would pop into character at the drop of a hat terrifying people on and off camera. Followed by a big smile and laugh. Thank you for being a good dude at heart. I miss you already."

Lister's manager, Cindy Cowan confirmed Lister was displaying symptoms

of COVID-19 in recent weeks and was diagnosed with the virus earlier this year. The 6-foot-5 entertainer was pronounced dead without the true nature of the cause on Thursday. "He was a gentle giant," Cowan said. "He had a smile as broad as you could imagine. He's going to be missed by so many. We're all devastated."

Lister was born as

Thomas Duane Lister on June 24, 1958. He had an athletic spirit, paired with the fire to perform. In 1982, he was an NCAA Shot-Put champion (division two), and he played for New Orleans Breakers of the United States Football League. Marrying the passion for sport and acting, Lister began to pursue the acrobatic art of wrestling. Lister proved to be agile

and tactful enough to take on the energy needed to be an actor.

Making ground in that field, by 1989, he was in the wrestling film "No Holds Barred," produced by the World Wrestling Federation, now known as WWE. His character "Zeus" was the arch-nemesis of WrestleMania legend Hulk Hogan in the featured film. He eventually won the WCW Championship belt under the title Z-Gangsta.

After carving his name into wrestling history, Lister continued the pathway of entertainment, seen in over 200 featured films and television credits according to his IMDB page. The Compton, California-born actor can be spotted in movies like "The Fifth Element," (President Lindberg, 1997), and "Zootopia," (voice of Finnick, 2016).

His talent knew no bounds as he performed in music videos, commercials, and video games.



Words of the Week - Stuff That's Driving Us Crazy

Scripture: Mark
5:1-11

It has been said that if you don't have a sense of humor, then you don't have any sense at all. Laughter, according to the wisdom writer in Proverbs 17:22, is good medicine for the soul.

One of my favorite comedians was George Carlin. Carlin was born May 12, 1937, in New York and died June 22, 2008, at the age of 71 in Santa Monica, CA. He was widely regarded as one of the most important and influential stand-up comedians of our time. One newspaper called him "the dean of counter-cultural comedians." He was second on Comedy Central's list of 100 greatest stand-up comedians.

While he was a good comedian with great critique of the social, political, and economic realities of his times, perhaps his most memorable comedic routine was performed in 1986 for the HBO special, "Comic Relief." In his classic routine about the "stuff" in our lives, Carlin said that our houses are only places for our "stuff."

Carlin made us laugh at our desire to own, collect, and hoard "stuff." When our houses become too small to house our stuff, Carlin said, we go buy bigger houses, or rent space, to store our "stuff." An entire business Carlin said has been created just to store our "stuff."

The man in this text had

stuff, but his stuff was no laughing matter. Verse 1 says that when Jesus had come to the country of the Gadarenes immediately after he got off the ship, he was met by a man who had some "stuff." Verse 2 says that the man had some unclean spirits. He had some stuff in his life that was driving him crazy.

His stuff had him living in a graveyard among the tombs (v.3a). His stuff had often caused him to be bound with chains and fet-

ters (vv.3b-4). His stuff had him crying and cutting himself with stones (v.5).

This appears to have been the sentiment of our nation for the last four years. The stuff of our President, Donald J. Trump, has been driving us crazy. Whenever we thought it couldn't get any worse, it did. The disinformation and habitual lying about anything - you name it, he lied about it. He is on record having lied more than 20,000 times over the

last four years.

His disrespect for the rule of law has been driving us crazy. From welcoming foreign interference with our elections, to using the office of president for personal financial gain, to frivolous lawsuits one after another to advance his political agenda, his disrespect for the rule of law has been driving us crazy.

Not only that, but his deception has been driving us crazy. The things that he

knew to be serious, he down played not to be as serious as it was - primarily the COVID-19 virus - has driven us crazy. Holding super spreader events at the White House and rallies in states where the virus is surging with no social distancing or face coverings has been driving us crazy.

In the text, Jesus recognized that this man had some "stuff." And in Verse 8, Jesus speaks not so much to the man, but He speaks to the unclean spirits in the man. Jesus speaks to the man's "stuff" - "come out of the man you unclean spirit (v.8)."

Then Jesus named the man's "stuff." In Verse 9, Jesus ask the unclean spirits what was their name? In the second part of that verse, the unclean spirits said that their name was Legion for they were many (v.9b).

After naming the man's "stuff," Jesus drove the "stuff" out of the man. In Verse 10, the unclean spirits asked Jesus not to send them out of the country. They saw a herd of swine, Verse 11 says, on the mountain and asked Jesus to let them go into the swine. But Verse 12 says that when the man's "stuff" became the swine's "stuff," they violently ran down the mountain into the sea and were choked or drowned in the sea (v.13).

After 18 interviews with President Trump, Bob Woodward drew two conclusions in his book, "Rage." The first was that Trump had lost his way, not only as president, but also as a human being and the second was that he was not

fit for the office of president.

That appears to be the sentiment of the nation with more the 77 million Americans who cast their vote for Joe Biden to be the next President. The nation is casting Donald J. Trump out.

As Jesus did in this text, we must cast out his narcissist "stuff" that has been driving us crazy to a place where it can never affect our national sanity again. We must cast it out to a place where racism, homophobia, xenophobia, misogyny, and lying are no longer tolerated as normative.

We must cast it out to a place where the rule of law is applicable to everybody and not even the president is above it. We must cast it out to a place where every vote cast is a vote counted and no vote is suppressed. We must cast it out to a place where civility, and truth telling, and facts, and data, and science, and national intelligence are valued and inform national decision-making.

Then will we be found clothed and in our right mind. Then will our ancestors rejoice and be glad knowing that their living was not in vain. Then will the fore parents of our nation shout for joy knowing that we are becoming a perfect union. Then will all heaven rejoice because the soul of our nation has been restored.

Let us once and for all rid ourselves of the "stuff" that has been driving us crazy. In the name of the Father, and the Son, and the Holy Ghost. Amen!


