

A Sampling of Our Work

Supporting Suppliers in the Industrial Transformation: State of Michigan

In Michigan, the epicenter of America's automotive industry, the shift towards vehicle electrification and clean energy is reshaping the landscape for businesses across automotive and industrial supply chains. Next Street is partnering on a multifaceted project that involves an in-depth analysis of automotive and industrial supply chains to assess opportunities and threats for local businesses and workers and chart a comprehensive strategy to support small and mid-sized suppliers in navigating Michigan's net-zero transition and the related economic effects.



We have mapped 4,400 supplier facilities in MI and nearly 980,000 employees that would be impacted across the state.

Empowering Untapped Entrepreneurs: City of Dayton

The City of Dayton made a commitment to support the growth of its Black and Brown-owned businesses and provide wealth-building opportunities to residents who were excluded or harmed by past policies. As part of that commitment, they engaged Next Street to support the launch of the Inclusive Business Recovery Opportunity Center, a brick-and-mortar business center that will provide support and resources to untapped entrepreneurs.

Our team analyzed the small business ecosystem in Dayton to identify gaps and opportunities and align local stakeholders. We then developed a business plan for the IBROC and are working with the City to identify and secure a host entity.

Creating Opportunity in the Offshore Wind Industry: NYCEDC **Offshore Wind and Waterfront Pathways Program**

In 2024 Next Street continued to deliver the Offshore Wind and Waterfront Pathways program, supporting diverse-led businesses to participate in the growing OSW industry.

The program helps participates become prequalified and competitive for NYC Economic Development Corporation contracts, receive on-site technical assistance, and pivot from adjacent industries into OSW infrastructure work.



To date, we have graduated 42 businesses that have closed more than \$11 million in offshore wind contracts with NYCEDC since completing the program.

Centralizing Resources across the Country: Cook County, IL

The Cook County Small Business Source is celebrating 5 years in 2025. Building from a small business ecosystem assessment Next Street conducted in 2018, we launched The Source in partnership with the Cook County Bureau of Economic Development. It brings together 50+ Business Service Organization partners and delivers a digital advising platform, a suite of resources and a grant program.









